Hello

I'm Steve Lankford, host of Health Quest Radio Show, and I have very important information for you. The Wisconsin Dietitians have introduced their bill into the Wisconsin Assembly Health and Health Care Committee. This is the same bad bill that was previously introduced in the Wisconsin Senate. Naturopathic Doctors, alternative practitioners, health food stores, nutritional counselors, network marketers as well as all the citizens of Wisconsin that will be deprived of access to alternative nutritional practices. Wisconsin Dietitians will control nutritional therapy. In the states where similar bills have passed, access to alternative nutritional services has been destroyed.

The response to our April initiative and our strong opposition at the Sept 17th hearing has resulted in the bill being stalled in the Senate committee. On Sept 23rd, Representative Pasch introduced the bill into the Assembly Health and Health Care committee, without changes and without any compromise or improvements. Therefore we must continue the fight.

Obtain the following:

- *Oppose_WI_AB_440.pdf* is a 1 page flyer that explains the problem and gives explicit instructions as to how each individual can act. Please review this flyer. It explains the issue in a nutshell and describes what to do.
- *Petition_Against_WI_AB_440.pdf*. **THIS IS A NEW PETITION.** Even if people signed the SB 115 petition, they should also sign this one. This goes to your Assembly representative and the Assembly chairman.
- *WI_AB_440_Resources_List.pdf*. Become informed and help us defeat the dietitians and preserve nutritional freedom. The documents and more can be downloaded at www.healthquestradioshow.com.

Here is what we are asking you to do:

- Duplicate the flyer and distribute to as many as you can. Explain the issues to consumers and urge them to take action and to call their state representative.
- Duplicate the petition and provide opportunities for citizens to sign. Send the originals of the signed petitions to YOUR Wisconsin Representative. Send copies to the committee chair and keep copies for yourself. If possible send copies to the WI Health Freedom Coalition.

If you will only do these things, it will be of tremendous benefit. The cost and effort for you is fairly small for the large amount of positive impact this can have on this effort.

Here is the next most important thing you can do:

Send a contribution to the Wisconsin Health Freedom Coalition. This is the group that has shouldered the expense of mounting a defense. As little as \$25 to \$100 would go far in helping fund the fight for health freedom. Please donate as soon and as much as you can.
